## New Department of Justice grant builds on successful re-entry program

Program aids offenders making the transition back into the workplace, family life

MILWAUKEE – September 22, 2011. The Center for Self-Sufficiency is the recipient of a new \$300,000 twoyear grant from the Department of Justice aimed at reducing the recidivism rate among criminal offenders and improving their positive life skills for re-entering society.

"This grant will build on our five years of experience in providing key pre-release programming for offenders to support their successful reintegration plan," says Angela Turner, president and CEO of the Center for Self-Sufficiency. "We are very pleased that we will be able to continue these efforts."

With this funding, the program is expected to aid about 120 Milwaukee-area participants within three to six months of their release from the criminal justice system. The programming relies on the assistance of about 30 volunteer mentors and 18 community organizations that offer a variety of specialized services, from teaching the participants employment skills to providing help with substance abuse, child care and transportation issues.
